BLOODBORNE PATHOGEN

This training session covers the following topics:

- Contents of the OSHA standard.
- Epidemiology & symptoms of Bloodborne diseases.
- Modes by which Bloodborne diseases are transmitted.
- The Exposure Control Plan.
- Personal hygiene and proper hand washing technique.
- Personal Protective Equipment.
- Practices to minimize risk of exposure and engineering controls.
- Signs, labels & containers.
- Use of Universal Precautions all textiles treated as contaminated regardless of color of textile bag.
- Emergency Procedures.
- Follow-up Procedures, business health.
- Hepatitis B vaccine program.
- What to do if there is a needled stick or other exposure

A training film, "Bloodborne Pathogens – Always Protect Yourself" is shown, the company's exposure control plan is distributed and discussed, any questions are addressed by the trainer, and a quiz is given to the employees to insure understanding

Back Safety

The training video "Back Safety Basics" is shown. This training film covers the following topics:

- Structure of the back.
- Common back problems.
- Proper lifting techniques.
- Proper posture.
- Maintaining a healthy back.

The trainer is available to address questions.

Understanding is verified by direct observation. The trainer, operations manager, supervisor and plant manager regularly observe the work practices of each employee to insure understanding and compliance with this material.

Hazard Communication

The training video "Hazard Communication: Your Key to Chemical Safety" by the Training Network is shown. This training film covers the following topics:

- Identifying chemicals; reading chemical labels.
- SDS (previously MSDS) sheets
- Proper storage of chemicals; emergency procedures.

The trainer covers the location of our SDS (previously MSDS) sheets and is available to answer questions.

Sexual Harassment

The film "Sexual Harassment in the workplace: Employee Basic Training" by the Training Network is shown. This training video covers the following topics:

- What constitutes sexual harassment.
- Behaviors to avoid
- Recognizing victims and harassers.
- How to handle a sexual harassment incident.
- Reporting sexual harassment to management

A trainer is present to address any questions and a quiz is given to check for understanding.

Grading System: Textile Quality Standards

All employees who handle finished textiles receive training on Textile Quality Standards when hired. This information is reviewed annually.

A copy of the textile standards is distributed and the information is covered by the trainer. Topics include:

- When is a stain acceptable and not acceptable
- How large can a hole be
- Textiles must be free of foreign objects
- Textiles must be fresh smelling and never damp
- Textiles standards for specific items are also covered

Examples of these standards are demonstrated and are later available to be viewed on the main bulletin board.

Understanding and compliance are verified by the Quality Control/ Recruiting Manager who regularly checks finished items to insure they meet these standards.

Separation of Clean and Soiled: Infection Control

All employees who work in the plant are trained in traffic flow patterns when they are hired and the information is reviewed annually.

A copy of the policy is distributed. The trainer goes over the material and is available to address questions. Topics covered include:

- The need to keep soiled textiles separate from clean
- Separate soiled and finish side docks
- The need to send any carts on the soiled side through the cart washer to get them to the finish side
- The need to remove PPE and wash hands if working on the soiled side prior to entering the clean side
- Proper Hand Washing technique
- Visitors to the plant must enter through the lobby

Understanding is verified by direct observation. The trainer, operations manager, supervisor and plant manager regularly observe the work practices of each employee to insure understanding and compliance with this material.

Lock-Out Tag-Out

Topics covered include:

- Stored energy
- Appropriate locking devices
- Energy control devices
- Communication between shifts

Confined Space

Topics include:

- What is a confined space?
- Hazards of confined spaces
- Hot work permits
- Proper procedures

A DVD is shown and a trainer is present. Understanding is verified by a written test.

- Defensive driving
- Use of right-hand mirror
- Off tracking
- Unmarked underpasses

GENERAL SAFETY TRAINING

An extensive review was made for each area of the plant analyzing all accidents and near misses. Where feasible, engineering controls have been put in place. In cases where changes could not be made, a list of topics to review with employees was developed. Our trainer takes each new employee through the plant and points out areas of concern and the safety rules applicable to them.

A checklist has been developed to ensure all areas are covered. Included in these checklists are the following:

General Safety:

- How to report an accident or malfunctioning piece of equipment
- How to report a near miss
- Location of SDS (previously MSDS) sheets
- Emergency Plans including Fire and Severe Weather
- Safety Rules Sheet

Soiled Area:

- Soiled Sling Pathway
- Soiled Sling Lift
- Chemical Room Restrictions
- Proper Method of Sorting Textiles (keep away from face, coworkers, etc)
- Location of Sharps Containers
- Location of PPE
- Hand Wash Station
- Stabilizer Plungers and Switches

- Cart Shelves
- Fire Alarms, Aisles, Exits
- Handling of regulated medical waste blood and OPIM

Washroom:

- Dryer Shuttle Cages
- Operation of Hoist
- Proper Loading of Slings
- Weight Limits
- Strapping Bag onto Hook
- Chemical Hazards
- Emergency Stop Buttons
- Equipment Guards
- Fire Alarms, Aisles, Exits

Finish Side:

- Proper Movement of Carts
- Fire Alarms, Aisles, Exits
- Emergency Stops
- Ironer Safety
- Jam Removal make sure equipment is turned off
- Conveyor Pinch Points
- How to Drop Textiles
- Wet Floor Areas
